This Product Disclosure Statement ("PDS") has been prepared and issued by Equity Trustees Limited ("Equity Trustees", "we" or "Responsible Entity") and is a summary of the significant information relating to an investment in the Pellucid Dynamic Fund (the "Fund"). # 1. About Equity Trustees Limited

## The Responsible Entity

### Equity Trustees Limited

Equity Trustees Limited ABN 46 004 031 298 AFSL 240975 ("Equity Trustees", "we", "us", the "Responsible Entity"), a subsidiary of EQT Holdings Limited ABN 22 607 797 615, which is a public company listed on the Australian Securities Exchange (ASX: EQT), is the Fund's responsible entity and issuer of this PDS. Established as a trustee and executorial service provider by a special Act of the Victorian Parliament in 1888, today Equity Trustees is a dynamic financial services institution which continues to grow the breadth and quality of products and services on offer.

Equity Trustees' responsibilities and obligations as the Fund's responsible entity are governed by the Fund's constitution ("Constitution"), the Corporations Act and general trust law. Equity Trustees has appointed Pellucid Asset Management Pty Ltd as the fund manager of the Fund. Equity Trustees has appointed a custodian to hold the assets of the Fund. The custodian has no supervisory role in relation to the operation of the Fund and is not responsible for protecting your interests.

## The Investment Manager

### Pellucid Asset Management

Pellucid Asset Management Pty Limited ("Pellucid", "Investment Manager") is the investment manager of both:

- this fund, the Pellucid Dynamic Fund ("Fund"), and
- the Pellucid Diversified Fund.

Generally speaking, the difference between the two is that the Pellucid Diversified Fund is less growth oriented, having lesser potential exposure to growth assets such as equities and more weighting to defensive assets. That orientation brings a medium risk rating, as opposed to this fund which is considered medium to higher risk.

As the Investment Manager, Pellucid selects and manages the assets of the Fund and may invest in other managed funds ("Underlying Funds") who are managed by other investment managers ("Underlying Fund Managers") to manage some or all of the Fund's assets through. Underlying Funds may be added or removed at any time.

Pellucid assumes operational and portfolio management responsibility for the Fund undertaking all duties including research and portfolio construction.

Pellucid's board comprises seasoned investment professionals, the majority of whom have had a long association with DMG Financial Planning Pty Ltd as well as the Fund. The chair of Pellucid's board is external and independent. If Board members are conflicted on an issue, then only non-conflicted directors may determine the issue.

Portfolio governance is enhanced by the Pellucid Investment Committee ("Investment Committee") which comprises senior investment professionals, a majority from outside the Investment Manager. The chair is also external and independent, and has a casting vote in the case of deadlock.

Pellucid has also implemented a comprehensive risk and compliance system, with a Compliance Committee comprising experienced professionals, again with an external chair.

## The Sub-Investment Manager

### K2 Corporate Services Pty Ltd

Pellucid has engaged K2 Corporate Services Pty Ltd ACN 641 203 438 ("K2 CIO Office", "Sub-Investment Manager") as its sub-investment manager for the Fund.

At the date of issue of this PDS, the K2 CIO Office manages around \$250 million under investment management agreements and advises on over \$300 million.

The K2 CIO Office is primarily responsible for investment due diligence, selection, research and portfolio modelling and construction. It also provides assistance with ongoing valuation, performance measurements and reporting, liquidity planning and asset and liability modelling.

The K2 CIO Office's team have a long and established track record managing various bespoke investment strategies, asset allocation, manager selection and monitoring of various clients currently and historically. The team has one of the longest running track records in the local market with regard to all aspects of multi-asset management across many different risk metrics reflected by various balanced funds. ## The Administrator and Custodian

### Apex

The Responsible Entity has appointed Apex Fund Services Pty Ltd ("Apex") as the administrator and also the custodian of the Fund.

Apex is part of Apex Group, established in Bermuda in 2003, which is a global financial services provider. Apex Group delivers an extensive range of services to asset managers, capital markets, private clients and family offices.

As the Administrator, Apex performs certain administrative, accounting and determining the net asset value ("NAV") and unit prices of the Fund under the Fund's valuation policies, maintaining the Fund's financial books and records and arranging distributions.

As the Custodian, Apex's role is limited to holding assets of the Fund.

Apex has no supervisory role in relation to the operation of the Fund. It does not make investment decisions in relation to the assets held or manage those assets, and has no liability or responsibility to investors in the Fund.

# 2. How the Pellucid Dynamic Fund works

The Fund is a registered managed investment scheme governed by its Constitution. The Fund comprises assets which are acquired in accordance with the Fund's investment strategy. Direct investors receive units in the Fund when they invest. In general, each unit represents an equal interest in the assets of the Fund subject to liabilities; however, it does not give investors an interest in any particular asset of the Fund.

If you invest in the Fund through an investment platform like an IDPS (as defined in the Reference Guide) you will not become an investor in the Fund. The operator or custodian of the IDPS will be the investor entered in the Fund's register and will be the only person who is able to exercise the rights and receive the benefits of a direct investor. Your investment in the Fund through the IDPS will be governed by the terms of your IDPS. Please direct any queries and requests relating to your investment to your IDPS Operator. Unless otherwise stated, the information in the PDS applies to direct investors.

## Applying for units

You can acquire units by completing the Application Form that accompanies this PDS. Payment instructions are on the Application Form. The minimum initial investment is \$1,000.

If you have a financial adviser, they can help you to invest.

We reserve the right to accept or reject applications in whole or in part at our discretion. We also have the discretion to delay applications processing.

The price at which units are acquired ("Application Price") is determined in accordance with the Constitution. The Application Price on a Business Day is, in general terms, equal to the Net Asset Value ("NAV") of the Fund, divided by the number of units on issue and adjusted for transaction costs ("Buy Spread"). At the date of this PDS, the Buy Spread is 0.20%.

The Application Price will vary as the market value of assets in the Fund rises or falls.

## Making additional investments

The minimum additional investment is \$100.

To make an additional investment, simply complete our Additional Investment Form available free from the Administrator or us. Post, fax or email your form to the Administrator.

Else use BPAY<sup>®</sup>. The Fund's Biller Code is 457416, and is also shown on the Application Form. You will be given your Customer Reference Number after your initial application. When making the payment via BPAY<sup>®</sup>, you do not need to complete an Additional Investment Form.

## Distributions

An investor's share of any distributable income is calculated in accordance with the Constitution and is generally based on the number of units held by the investor at the end of the distribution period.

The Fund usually distributes income at least annually at the end of June. Equity Trustees may distribute more frequently at its discretion and may change the distribution frequency without notice. Distributions are calculated effective the last day of each distribution period and are normally paid to investors as soon as practicable after the distribution calculation date.

Investors can choose to have their distribution:

- reinvested back into the Fund; or
- directly credited to their AUD Australian domiciled bank account.

Investors who do not choose will have their distributions automatically reinvested. Applications for reinvestment will be taken to be received immediately prior to the next Business Day after the relevant distribution period. There is no Buy Spread on distributions that are reinvested.

In some circumstances, an investor's withdrawal proceeds are taken to include a component of distributable income.

Indirect Investors should review their IDPS Guide for information on how and when they receive any income distribution.

## Access to your money

Investors in the Fund can generally withdraw their investment by completing a written request to withdraw from the Fund and mailing it to:

The minimum withdrawal amount is \$1,000. Once we receive and accept your withdrawal request, we may act on your instruction without further enquiry if the instruction bears your account number or investor details and your (apparent) signature(s), or your authorised signatory's (apparent) signature(s).

Equity Trustees will generally allow an investor to access their investment within 14 days of acceptance of a withdrawal request by transferring the withdrawal proceeds to such investor's nominated Australian domiciled financial institution account. Equity Trustees is, under the Constitution, allowed to reject withdrawal requests, and also to make payment up to 21 days after acceptance of a request (which may be extended in certain circumstances) as outlined in Reference Guide.

We reserve the right to accept or reject withdrawal requests in whole or in part at our discretion.

The price at which units are withdrawn is determined in accordance with the Constitution ("Withdrawal Price"). The Withdrawal Price on a Business Day is, in general terms, equal to the NAV of the Fund, divided by the number of units on issue and adjusted for transaction costs ("Sell Spread"). At the date of this PDS, the Sell Spread is 0.20%. The Withdrawal Price will vary as the market value of assets in the Fund rises or falls.

Equity Trustees reserves the right to fully redeem your investment if your investment balance in the Fund falls below \$1,000 as a result of processing your withdrawal request.

In certain circumstances, for example, when there is a freeze on withdrawals, where processing a withdrawal is not in the best interests of investors in the Fund (including due to one or more circumstances outside its control) or where the Fund is not liquid (as defined in the Corporations Act), Equity Trustees can deny or suspend a withdrawal request and you may not be able to withdraw your funds in the usual processing times or at all.

When the Fund is not a liquid scheme (as the Corporations Act defines this), an investor can only withdraw when and if Equity Trustees makes a withdrawal offer to all investors in accordance with the Corporations Act. Equity Trustees is not obliged to make such offers. Even if such an offer is made, you may not be able to withdraw all your investment.

If you are an Indirect Investor, you need to provide your withdrawal request directly to your IDPS Operator. The time to process a withdrawal request will depend on the particular IDPS Operator and the terms of the IDPS.

### Unit pricing discretions policy

Equity Trustees has developed a formal written policy in relation to the guidelines and relevant factors taken into account when exercising any discretion in calculating unit prices (including determining the value of the assets and liabilities). A copy of the policy and, where applicable and to the extent required, any other relevant documents in relation to the policy will be made available free of charge on request.

### Additional information

If and when the Fund has 100 or more direct investors, it will be classified by the Corporations Act as a 'disclosing entity'. As a disclosing entity, the Fund will be subject to regular reporting and disclosure obligations. Investors would then have a right to obtain a copy, free of charge, of any of the following documents:

- the most recent annual financial report lodged with ASIC ("Annual Report");
- any subsequent half yearly financial report lodged with ASIC after the lodgement of the Annual Report; and
- any continuous disclosure notices lodged with ASIC after the Annual Report but before the date of this PDS.

Equity Trustees will comply with any continuous disclosure obligation by lodging documents with ASIC as and when required.

Copies of these documents lodged with ASIC in relation to the Fund may be obtained from ASIC through ASIC's website.

## 3. Benefits of investing in the Pellucid Dynamic Fund

### 3.1. Significant features

Investing in the Fund is designed to provide exposure to a diversified portfolio focusing more on growth investments, targeting exposure of 90% in growth assets and 10% in defensive assets as a neutral position.

Utilising rigorous portfolio construction and risk management techniques, the Investment Manager aims to enhance the long term return potential whilst maintaining some measure of capital preservation.

The Fund is very much a growth-oriented investment portfolio, with the flexibility to be managed more conservatively or aggressively as determined by the Investment Manager.

### 3.2. Significant benefits

Some of the significant benefits of the Fund include:

- professional active investment management,
- competitive costs,
- easy access to your investment in normal market conditions,
- medium to high risk,
- a very high level of diversification, and
- accessing many investments and Underlying Fund Managers not ordinarily available to investors.

## 4. Risks of managed investment schemes

### Risks of managed investment schemes

All investments carry risks. Different investment strategies may carry different levels of risk, depending on the assets acquired under the strategy. Assets with the highest long-term returns may also carry the highest level of short-term risk. The significant risks below should be considered in light of your risk profile when deciding whether to invest in the Fund. Your risk profile will vary depending on a range of factors, including your age, the investment time frame (how long you wish to invest for), your other investments or assets and your risk tolerance.

None of the Responsible Entity, the Investment Manager or the Sub-Investment Manager guarantee the liquidity of the Fund's investments, repayment of capital or any rate of return or the Fund's investment performance. The value of the Fund's investments will vary. Returns are not guaranteed, and you may lose money by investing in the Fund. The level of returns will vary and future returns may differ from past returns. Laws affecting managed investment schemes may change in the future. The structure and administration of the Fund is also subject to change.

In addition, we do not offer advice that takes into account your personal financial situation, including advice about whether the Fund is suitable for your circumstances. If you require personal financial or taxation advice, you should contact a licensed financial adviser and/or taxation adviser.

### Market risk

This is the risk that an entire market, country or economy changes in value or becomes more volatile. Reasons can include changes in economic, the environment, financial, technological, public health, political or legal conditions, natural and man-made disasters, conflicts, social rules and laws and changes in market sentiment.

In particular, economic and other risks have increased as a consequence of matters such as: global pandemic, increasing political volatility, the rise of nationalism, higher interest and inflation rates, significant political and associated policy developments and uncertainties in the US and also in other places, and geopolitical tensions such as those involving the US and the rest of the world as well as those in the Taiwanese Strait, the Middle East, Southwest Asia, Sudan and Eastern Europe.

Many believe that the overall investment markets may meet a substantial adjustment, having been performing positively for an extended period. This cannot be discounted: markets tend to follow cycles. But recent times have also shown that markets also behave illogically at times, with asset classes moving differently to historical norms.

The Investment Manager and the Sub-Investment Manager monitor markets globally, undertaking their own research as well as analysing market research, and use tools to model Fund behaviour under various conditions. The Fund's investment exposure is very diversified across markets and is repositioned strategically as considered appropriate. However diversifying, and investing for the long term, help manage the overall impact of ups and downs.

### Investment risk

This is the risk that the value of an investment in the Fund's portfolio such as equities may change or become more volatile, potentially causing a loss.

Reasons may include changes in an investment's operations, management or business environment, or what people think of the investment.

The Investment Manager and the Sub-Investment Manager select and monitor the underlying investments and Underlying Fund Managers carefully, and changes it when they think it appropriate.

The Fund's investment exposure is very diversified and limits are set for the amount held in each asset class.

### Alternatives risk

Through Underlying Funds, the Fund gives investors exposure to alternative investments.

Alternative assets refer to investments outside traditional asset classes like equities and bonds. They can include areas such as private equity, hedge funds, infrastructure, real estate, distressed assets, and digital assets.

These investments span a wide risk spectrum, and Underlying Funds operating in this space range from low to high risk. Apparent risk levels, for example those associated with distressed or digital assets versus infrastructure or hedge funds, may not reflect actual risk, which depends on the specific fund and how its risks are managed.

Key risks include variable regulation, limited transparency, complex investment strategies, difficulties in valuation, managing inherent conflicts, issues with co-investment arrangements, uncertain exit paths, and the use of leverage.

Early-stage investments also carry risks such as a lack of track record or experienced management, challenges entering markets and raising capital, regulatory uncertainty, intellectual property risks, intense competition, limited reporting transparency, dependence on key personnel, and difficulties in scaling and commercialising the business.

### **Property & infrastructure risk**

Through Underlying Funds, the Fund gives investors exposure to property and infrastructure investments.

Property and infrastructure investments offer potential for stable income and long-term growth but come with specific risks. Asset values can fall due to economic conditions, interest rate changes, or declining demand, and these assets are often illiquid, making them difficult to sell quickly. Valuations may be infrequent or uncertain, and development projects can face delays or cost overruns. Income may be impacted by tenant defaults, vacancies, or changes in usage trends. Regulatory changes, poor management, and unexpected maintenance costs can also affect returns. Use of leverage adds further risk, potentially amplifying losses if values fall or cash flow weakens.

### **Lending risk**

The Fund may seek returns by or through exposure to lending.

Borrowers may default due to a combination of internal and external factors. Key risks include economic downturns, limited access to capital, poor management or governance, inadequate financial planning, loss of key personnel, rising input and energy costs, supply chain and distribution disruptions, legal disputes, and regulatory or tax changes. Other significant risks include technological disruption, reputational damage, labour shortages, insufficient insurance, and market competition.

While borrowers may provide security, there is a risk they may default or be unable to meet payment obligations. In such cases, enforcement depends on the value and enforceability of the security, and whether recoveries are sufficient. Asset sales may not fully repay outstanding amounts, especially if values fall, guarantees lack substance, or other lenders have priority. Enforcement may be costly, delayed, or unsuccessful, and issues with documentation can hinder recovery. Loan terms may also be extended, which can affect expected returns.

### **Interest and inflation rates risk**

This risk refers to how rising interest rates and inflation can reduce the value or returns of investments.

Interest rates are mainly driven by inflation, economic growth, unemployment, global market trends, and the Reserve Bank's goals—like keeping inflation stable and supporting jobs.

Inflation rises when demand exceeds supply (demand-pull), or when business costs like wages or fuel increase (cost-push). Low interest rates, a falling Australian dollar, and expectations of future price rises also contribute.

When both interest rates and inflation rise, share portfolios often fall in value. Higher rates make borrowing more expensive and reduce spending, hurting company profits. Investors may shift to safer options like bonds. Inflation also raises business costs and uncertainty, though some sectors—like energy, banks, and consumer staples—can perform better in these conditions.

### **International and currency risk**

Companies and Underlying Funds in which the Fund invests will often have exposure to offshore markets and non AUD currencies.

Some international exposures are more affected by political and economic uncertainties, lower regulatory supervision and possibly more volatile, less liquid markets. Developing and more so emerging markets are generally less sophisticated with less evolved reporting, governance and regulatory frameworks, and greater political, legal and other risks, than developed markets.

Currency risk also arises from investing internationally. Companies and Underlying Funds in which the Fund invests may or may not hedge their exposure, and even if hedged, this will not always provide complete protection from risk.

Investors in the Fund will be affected indirectly by International and currency risks.

### **Liquidity risk**

This is the risk that your withdrawal requests cannot be met when you expect. Cash is paid to your account when you withdraw, and as such investments of the Fund may need to be sold to satisfy your withdrawal request.

Depending on factors such as the state of the markets and the liquidity profile of particular investments, selling sufficient investments in a timely manner is not always possible, practicable or consistent with the best interests of all investors.

Unlisted company investments, Underlying Funds with withdrawal restrictions and loans by and loan exposure of the Fund with fixed terms or which are in default for example are less liquid exposures. Additionally, if the Fund reduces in size it is possible that the overall liquidity profile of the portfolio will deteriorate, which may mean that accessing your investment when you want is less likely.

This is one of the reasons why the Constitution specifies limited circumstances where there could be a delay in meeting your withdrawal requests. The law sometimes also restricts withdrawals.

The Fund is not listed on any stock exchange, so you cannot sell (ie transfer) your units through a stockbroker and, although you may sell your units, you may not find a buyer or a buyer at the price you want.

The Fund seeks to meet withdrawal requests soon after the Fund receives them. The Investment Manager does this by monitoring Fund liquidity and transaction levels and seeks to ensure it has, or anticipates having access to, enough liquid assets for when it is anticipated they would normally be needed.

### **Derivatives risk**

Derivatives are contracts between two parties that derive value from an underlying asset or index.

The Fund does not use derivatives. Companies and Underlying Funds in which the Fund invests may use derivatives as part of their business operations, for example to enhance returns, manage financial risks or optimise capital efficiency.

Derivatives magnify returns and also losses. They may result in leverage—where the company's or Underlying Fund's effective exposure to certain assets, asset classes or financial risks exceeds the value recorded on its balance sheet. Derivatives use can increase volatility in earnings, potential capital losses and counterparty or liquidity risk, depending on how they are deployed.

Unfortunately using derivatives to reduce Fund risk is not always successful, is not always used to offset all relevant Fund risk, and is sometimes not cost effective or practical to use.

Derivatives use is assessed as part of the due diligence conducted in relation to potential investments. It is not practicable to give investors the maximum anticipated level of leverage, because derivatives use varies.

### **Borrowing risk**

Borrowing has the ability to magnify returns and also losses.

The Fund does not borrow. Companies and Underlying Funds in which the Fund invests may borrow. Borrowing levels and any limits are assessed as part of the due diligence conducted in relation to potential investments. It is not practicable to give investors the maximum anticipated level of underlying borrowing, because levels vary.

### **New economy risk**

The world is shifting and more and more companies are dealing with the growing impact of the emerging digital economy, transacting using blockchain, and navigating the decentralised and non-institutional world offered. Along with many new opportunities, there are also new challenges to be faced. Companies and Underlying Funds in which the Fund invests face some new risks, as well as well-known risks being heightened in some cases, lowered in others. The Investment Manager is mindful of this quickly changing environment and assesses the way that companies seek to exploit digital economy opportunities and manage digital economy risks. Nonetheless, gains and losses can be dramatic.

### **Structure risk**

This is the risk associated with having someone invest for you.

Risks associated with investing in the Fund include that it could be terminated, there can be changes in the responsible entity or chosen investment or sub-investment manager (or in investment and management teams or key relationships), someone involved with your investment (even remotely) does not meet their obligations or perform as expected, assets may be lost, not recorded properly or misappropriated, laws may adversely change, insurers may not pay when expected or insurance may be inadequate.

Investment decisions that have been made previously may not always have been optimal.

Investing through an administration platform also brings some risks that the operator of the platform may not perform its obligations properly.

Investing in the Fund may give inferior results compared to investing directly (for example you avoid the impact of others investing and withdrawing).

We diligently comply with laws. Disaster recovery systems and procedures are regularly tested. Insurance is maintained as law requires. We employ a range of people we trust, who are ethical, experienced and professional.

### **Information and cyber risk**

The Fund's portfolio may be exposed to the developing digital economy, where regulation and infrastructure that is still emerging, risks can be higher and asset values can be extremely volatile. There can still be substantial, immediate, complete and irrecoverable loss when exposed to this market.

Additionally, the impact of programs and the growth of 'artificial intelligence' and associated learning models as well as the potential emergence of general artificial intelligence and the ongoing development of quantum computing, could have an adverse as well as a positive impact on the operation of the Fund. One adverse possibility is that it becomes more difficult to have a high level of confidence regarding information sourced from the Internet and on which decisions affecting the Fund and its investment exposure is based.

We use the internet in operating the Fund, including records that may be stored in remote server locations otherwise known as "the cloud". If stored overseas, different privacy and other standards may apply there.

The internet does not always result in a secure information environment. We are committed to ensuring that your information is kept secure and protected from misuse and loss and from unauthorised access, modification and disclosure. Although we take steps we consider reasonable to protect your information, we cannot absolutely guarantee its security. Our Privacy Policy is discussed below and in the RG.

### Service Provider risk

The reliance on external service providers such as the Investment Manager, the Sub-Investment Manager, the Administrator and the Custodian presents a risk if they default in performing their obligations, potentially causing loss to the Fund and requiring an alternative supplier. Further, losses can be incurred if a counterparty (such as a broker) defaults on their contractual obligations or experiences financial difficulty.

### Change risk

This describes risks associated with working to optimise the Fund's portfolio. Investment decisions by prior investment managers may be considered sub optimal by the Investment Manager, and there can be costs and delays in undoing these positions. These investments and this process can impact adversely on the Fund, including on returns and the liquidity profile.

This also describes the risk associated with the terms on which you invest changing. The Constitution and this PDS and the Reference Guide, as well as the Target Market Determination, can be amended: prior notice is generally not given and Investor approvals are not needed, unless law requires. Be aware that you may not be able to withdraw from the Fund before changes commence, amendments may be adverse to investor rights, and amendments may be adverse to an investor's interests or the interests of investors as a whole. In considering how to use our trustee powers and directions, we will usually take into account the things and other matters that investors have agreed or acknowledged.

### Pandemic and other unforeseen event risk

Health crises, such as pandemic and epidemic diseases, as well as other catastrophes that interrupt the expected course of events, such as natural disasters, war or civil disturbance, acts of terrorism, power outages and other unforeseeable and external events, and the public response to or fear of such diseases or events, have and may in the future have an adverse effect on the economies and financial markets either in specific countries or worldwide and consequently on the value of the Fund's investments. Further, under such circumstances the operations, including functions such as trading and valuation, of the Investment Manager and other service providers could be reduced, delayed, suspended or otherwise disrupted.

## 5. How we invest your money

**Warning:** When choosing to invest in the Fund, you should consider the likely investment returns, the risks of investing and your investment time frame.

### Investment objective

Our objectives are to achieve, over rolling 10-year periods:

- returns, after fees and expenses, of 6% p.a. above the Fund's benchmark, and
- reduce, but not eliminate, the losses and volatility usually experienced in financial markets.

Neither of these are guaranteed, forecast or promised.

The Fund's benchmark is the 30-day RBA one-month average for bank accepted bills/negotiated certificates of deposit (the "Benchmark").

### Asset allocation

The Investment Manager intends that the Fund maintains a long-term average exposure of 90% to growth assets and 10% to defensive assets.

This is compared to the Pellucid Diversified Fund where the Investment Manager intends that the fund maintains a long-term average exposure of 70% to growth assets and 30% to defensive assets.

The actual weighting will change and vary from these numbers due to a variety of factors including the mix between defensive and growth to align with the Fund's strategy and market movements. From time to time target exposures can be exceeded.

The Sub-Investment Manager works with the Investment Manager with the goal of delivering optimising asset allocation. This includes:

- developing strategic asset allocation benchmarks,

- developing the tactical asset allocation overlay investment process, and
  - the selection (both qualitative and quantitative) of Underlying Fund Managers and Underlying Funds across all asset classes, and
  - monitoring Underlying Fund Managers and their strategies,
- through to bespoke block-building of specific asset class exposures to complement expected return targets and risk tolerance.

The Sub-Investment Manager reviews and monitors the Fund portfolio targeting achieving the return objectives and monitoring portfolio risk.

### Changing the investment strategy

The investment strategy and asset allocation parameters may be changed. If a change is to be made, investors in the Fund will be notified in accordance with the Corporations Act.

### Labour Standards, Environmental, Social and Ethical Factors ("ESG considerations")

EQT has delegated investment decisions including ESG considerations to the Investment Manager. The Investment Manager will not take ESG considerations into account in the selection, retention and realisation of fund assets.

### Fund performance

Up to date information on the performance of the Fund can be obtained from [www.pellucidfunds.com.au](http://www.pellucidfunds.com.au). A free of charge paper copy of the information is available on request.

### Minimum suggested time frame

The minimum suggested investment time frame for the Fund is 7 years or more.

### Risk level

Medium to high.

### Investor suitability

The Fund is considered medium to high risk and is likely to be suitable for investors who are seeking capital growth over the longer term with the ability to bear 3 to 4 negative annual returns over a 20 year period and no need for income more than annually.

### Investment style and approach

The Fund's approach aims to help investors achieve two objectives:

- grow wealth and income faster than inflation over a long-term time horizon, and
- manage short-term capital instability caused by investment markets.

Over the longer run, the Investment Manager's intention is that asset exposure is represented by a relatively stable selection of Underlying Fund Managers and Underlying Funds: funds managed by local and offshore fund managers that have met rigorous due diligence requirements and are considered best of breed. The Investment Manager intends that the portfolio, once stable, will represent engagement with 10 to 20 Australian and offshore fund managers who it believes are best placed to produce attractive returns for investors from their specific investment focus. Long term, the intention is that there would be less emphasis on direct investments and loan exposure.

Goals include:

- positioning the Fund with the appropriate underlying asset exposure with the goal to achieve the investment objectives based on forward looking scenarios, asset class valuation models, and focused research, focussing on growth assets but able to adopt defensive positions in a manner designed to provide a measure of downside protection when markets fall,
- investing across different markets, Underlying Fund Managers and Underlying Funds using a rigorous due diligence process,
- a greater focus on capital growth whilst seeking some measure of protection against major capital losses during difficult market conditions, including through the use of alternative investment and other portfolio protection strategies, and
- taking a long term approach.

## 6. Fees and costs

### DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns.

For example, total annual fees and costs of 2% of your investment balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs.

You may be able to negotiate to pay lower fees. Ask the Fund or your financial adviser.

### Additional Explanation of Fees and Costs

#### Management fees and costs

The management fees and costs include amounts payable for administering and operating the Fund, investing the assets of the Fund, expenses and reimbursements in relation to the Fund and indirect costs if applicable.

Management fees and costs do not include performance fees or transaction costs, which are disclosed separately.

The management fees component of management fees and costs of 0.73% p.a. of the NAV of the Fund is payable to the Responsible Entity of the Fund for managing the assets and overseeing the operations of the Fund. The management fees component is accrued daily and paid from the Fund monthly in arrears and reflected in the unit price. As at the date of this PDS, the management fees component covers certain ordinary expenses such as Responsible Entity fees, investment management fees, custodian fees, and administration and audit fees.

The indirect costs and other expenses component of 0.84% p.a. of the NAV of the Fund may include other expenses of operating the Fund (both ordinary and other expenses), as well as management fees and costs (if any) arising from interposed vehicles in or through which the Fund invests. The indirect costs and other expenses component is variable and reflected in the unit price of the Fund as the relevant fees and costs are incurred. They are borne by investors, but they are not paid to the Responsible Entity or Investment Manager. The indirect costs and other expenses component is based on the relevant costs incurred during the financial year ended 30 June 2025.

Actual indirect costs for the current and future years may differ. If in future there is an increase to indirect costs disclosed in this PDS, updates will be provided on Equity Trustees' website at [www.eqg.com.au/insto](http://www.eqg.com.au/insto) where they are not otherwise required to be disclosed to investors under law.

Performance fees include amounts that are calculated by reference to the performance of interposed vehicles through which the Fund invests. The performance fees for the Fund are 0.16% of the NAV of the Fund. The performance fee figure that is disclosed in the Fees and Costs Summary is generally based on an average of the performance fees over the previous five financial years, where each performance fee relevant to the Fund is averaged and totalled to give the performance fees for the Fund.

In respect of an interposed vehicle that was not in operation for the previous five financial years, the performance fee average is calculated by reference to the number of financial years in which the interposed vehicle was operated.

Please note that the performance fees disclosed in the Fees and Costs Summary is not a forecast as the actual performance fee for the current and future financial years may differ. The Responsible Entity cannot guarantee that performance fees will remain at their previous level or that the performance of the interposed vehicles will outperform their Benchmarks.

It is not possible to estimate the actual performance fee payable in any given period, as we cannot forecast what the performance of the Fund will be. Information on current performance fees will be updated from time to time and available at [www.eqt.com.au/insto](http://www.eqt.com.au/insto).

#### Transaction costs

In managing the assets of the Fund, the Fund may incur transaction costs such as brokerage, buy-sell spreads in respect of the underlying investments of the Fund, settlement costs, clearing costs and applicable stamp duty when assets are bought and sold. Transaction costs also include costs incurred by interposed vehicles in which the Fund invests (if any), that would have been transaction costs if they had been incurred by the Fund itself. Transaction costs are an additional cost to the investor where they are not recovered by the Buy/Sell Spread, and are generally incurred when the assets of the Fund are changed in connection with day-to-day trading or when there are applications or withdrawals which cause net cash flows into or out of the Fund.

The Buy/Sell Spread that is disclosed in the Fees and Costs Summary is a reasonable estimate of transaction costs that the Fund will incur when buying or selling assets of the Fund. These costs are an additional cost to the investor but are incorporated into the unit price and arise when investing application monies and funding withdrawals from the Fund and are not separately charged to the investor. The Buy Spread is paid into the Fund as part of an application and the Sell Spread is left in the Fund as part of a redemption and not paid to Equity Trustees or the Investment Manager. The estimated Buy/Sell Spread is 0.20% upon entry and 0.20% upon exit. The dollar value of these costs based on an application or a withdrawal of \$1,000.00 is \$2.00 for each individual transaction. The Buy/Sell Spread can be altered by the Responsible Entity at any time and [www.eqt.com.au/insto](http://www.eqt.com.au/insto) will be updated as soon as practicable to reflect any change. The Responsible Entity may also waive the Buy/Sell Spread in part or in full at its discretion. The transaction costs figure in the Fees and Costs Summary is shown net of any amount recovered by the Buy/Sell Spread charged by the Responsible Entity.

Transaction costs generally arise through the day-to-day trading of the Fund's assets and are reflected in the Fund's unit price as an additional cost to the investor, as and when they are incurred.

The gross transaction costs for the Fund are 0.15% p.a. of the NAV of the Fund, which is based on the relevant costs incurred during the financial year ended 30 June 2025.

However, actual transaction costs for future years may differ.

#### Can the fees change?

Yes, all fees can change without investor consent, subject to the maximum fee amounts specified in the Constitution. The current maximum management fee to which Equity Trustees is entitled is 2.00% of the gross asset value ("GAV") of the Fund. However, Equity Trustees does not intend to charge that amount and will generally provide investors with at least 30 days' notice of any proposed increase to the management fees component of management fees and costs. In most circumstances, the Constitution defines the maximum level that can be charged for fees described in this PDS. Equity Trustees also has the right to recover all reasonable expenses incurred in relation to the proper performance of its duties in managing the Fund and as such these expenses may increase or decrease accordingly, without notice.

#### Payments to IDPS Operators

Subject to the law, payments may be made to some IDPS Operators because they offer the Fund on their investment menus. Product access is paid by the Investment Manager out of its investment management fee and is not an additional cost to the investor.

#### Differential fees

The Investment Manager may from time to time negotiate a different fee arrangement (by way of a rebate or waiver of fees) with certain investors who are Australian Wholesale Clients who invest significant amounts. Please contact the Investment Manager on 1300 553 463 for further information.

### Who can invest?

Anyone can invest directly however individual investors must be 18 years of age or over. Investors investing through an IDPS should use the Application Form provided by the operator of the IDPS.

### Cooling off period

If you are a Retail Client you may have a right to 'cool off' in relation to an investment in the Fund within 14 days of the earlier of:

- confirmation of the investment being received or available; and
- the end of the fifth business day after the units are issued or sold.

No cooling off applies if you are a Wholesale Client.

A Retail Client may exercise this right by notifying Equity Trustees in writing. A Retail Client is entitled to a refund of their investment adjusted for any increase or decrease in the relevant Application Price between the time we process your application and the time we receive the notification from you, as well as any other tax and other reasonable administrative expenses and transaction costs associated with the acquisition and termination of the investment.

The right of a Retail Client to cool off does not apply in certain limited situations, such as if the issue is made under a distribution reinvestment plan, switching facility or represents additional contributions required under an existing agreement. Also, the right to cool off does not apply to you if you choose to exercise your rights or powers as a unit holder in the Fund during the 14 day period, this could include selling part of your investment or switching it to another product.

Indirect investors should seek advice from their IDPS Operator as to whether cooling off rights apply to an investment in a fund by the IDPS. The right to cool off in relation to a fund are not directly available to an indirect investor. This is because an indirect investor does not acquire the rights of a unit holder in a fund. Rather, an indirect investor directs the IDPS Operator to arrange for their monies to be invested in a fund on their behalf. The terms and conditions of the IDPS Guide or similar type document will govern an indirect investor's investment in relation to a fund and any rights an indirect investor may have in this regard.

  - i. holds an Australian financial services licence authorising it to provide custodial or depository services under the Corporations Act 2001; or
  - ii. is exempt under the Corporations Act 2001 from the requirement to hold such a licence; and
- d) either:
  - i. satisfies one of the 'geographical link' tests in subsection 6(6) of the AML/CTF Act; or
  - ii. has certified in writing to the relevant reporting entity that its name and enrolment details are entered on the Reporting Entities Roll; and
- e) has certified in writing to the relevant reporting entity that it has carried out all applicable customer identification procedures and ongoing customer due diligence requirements in accordance with Chapter 15 of the AML/CTF Rules in relation to its underlying customers prior to, or at the time of, becoming a customer of the reporting entity.
